On May 28, 2026, Spire Missouri Inc. (Spire) filed the above-referenced application. Spire seeks a certificate of convenience and necessity (“CCN”) to construct, install, own, operate, maintain, and otherwise control and manage a natural gas system to provide natural service in Platte County, Missouri.

The Commission will direct notice of the application to be given to the Platte County Commission and local media in Platte County. The Commission will set a deadline for interested parties to intervene.

2. The Commission’s Public Information Officer shall make notice of this order available to the media serving Platte County, Missouri.

The application shall be filed in the Commission’s Electronic Filing and Information System (“EFIS”) or with the Secretary of the Commission. Comments on the Application may also be made in EFIS.

4. This order shall be effective when issued.
