Dear Judge Dippell,

On behalf of Missouri-American Water Company (“MAWC” or “Company”), I am providing to the Missouri Public Service Commission (“Commission”) for filing tariff sheets in electronic form. The tariff sheets are being filed pursuant to the *Partial Stipulation and Agreement* approved by the Commission in Case No. WR-2024-0320, wherein MAWC agreed that within one year of the effective date of rates of that case, it would file new tariff service area maps and legal descriptions where necessary to define existing certificated area boundaries in a way that is consistent with Staff’s current preferences. MAWC has filed an Application and Motion for Waivers in conjunction with this tariff filing.

The proposed tariff sheets are listed on **Appendix A**, bear a date of issue of May 28, 2026, and an effective date of June 27, 2026.
