The Commission is correcting its *Order Denying Discovery Motion*, issued on May 29, 2026, *nunc pro tunc* under Commission Rule 20 CSR 4240-2.160(4), to correct a referenced due date.

The final paragraph of the body of the order incorrectly referenced a Staff recommendation being due June 18; however, the correct due date is June 8.¹

Therefore, the Commission corrects the first sentence of the final paragraph of the body of the order to read as follows: “Lastly, the Commission notes that the Staff recommendation regarding the customer service and billing metrics (which relate to the tariff sheets currently suspended until July 4) is not due until June 8.”
