ORDER DIRECTING RESPONSE

On May 29, 2026, the Commission issued its *Order Directing Notice, Setting an Intervention Deadline, and Directing the Commission’s Staff to File a Pleading*. That order set an intervention deadline of June 29, 2026, and directed a Staff pleading by June 10, 2026. After that order was issued, the Regulatory Law Judge became aware of accompanying tariff revisions, Tracking Nos. JW-2026-0149 and JS-2026-0150, each bearing an effective date of June 27, 2026.

Therefore, the Commission will direct its Staff to respond stating whether these tariff revisions need to be suspended during the certificate case. The Commission will also set a time for any other responses to this order.

THE COMMISSION ORDERS THAT:

1. No later than June 4, 2026, the Commission’s Staff shall file a pleading stating whether these tariff revisions should be suspended pending an outcome in these certificate cases.

2. Any other responses to this order are due no later than June 4, 2026.
3. This order is effective when issued.
