ORDER RECOGNIZING NAME CHANGE

On May 21, 2026, the Commission received a letter from N.W. Communications Co.¹ d/b/a Fastwyre Broadband advising that it has;

- changed its corporate form from a corporation to a limited liability company;
- changed its name to N.W. Communications Co., LLC reflective of the changed corporate form; and
- changed its fictitious name to Socket Fiber.

The Commission has reviewed the filings and Commission Rule 20 CSR 4240-28.011(2) and finds the company has complied with all statutory and regulatory requirements for changing its name. The Commission will recognize the name change.

The Commission finds it reasonable for this order to become effective in less than 30 days.
