**ORDER DIRECTING NOTICE, ESTABLISHING INTERVENTION DEADLINE,  
AND DIRECTING STAFF RECOMMENDATION**

On June 2, 2026, Evergy Metro, Inc. d/b/a Evergy Missouri Metro and Evergy Missouri West, Inc. d/b/a Evergy Missouri West (collectively, Evergy) filed revised tariff sheets, with supporting testimony, to adjust charges related to their approved Demand Side Investment Mechanism (DSIM) Riders. The tariff sheets bear an effective date of August 1, 2026, and have been assigned Tracking Nos. JE-2026-0158 and JE-2026-0159, respectively.

Commission Rule 20 CSR 4240-20.093(4)(B) requires the Staff of the Commission (Staff) to examine and analyze the information Evergy has filed and to submit a recommendation no later than 30 days after Evergy filed its tariff revisions. Under the same rule, the Commission has 60 days to act on Evergy’s tariff revisions.

Commission Rule 20 CSR 4240-20.093(15)(A) provides that the parties to Evergy’s previous cases where a demand-side program was approved “shall have the right to be a party to any subsequent related periodic rate adjustment proceeding without the necessity of applying to the [C]ommission for intervention; however, such person or entity shall file a

notice of intention to participate within the intervention period.” Thus, the parties to Case Nos. EO-2023-0369 and EO-2023-0370 may become parties to this proceeding by filing a notice as set out below.

The Commission will establish a deadline for the filing of applications to intervene and direct its Data Center to serve a copy of this order upon the parties in Case Nos. EO-2023-0369 and EO-2023-0370 and upon the county commissions of each county in Evergy’s service areas. In addition, the Commission’s Public Policy and Outreach Department shall make notice of this order available to the media serving Evergy’s service areas.

**THE COMMISSION ORDERS THAT:**

1. The Commission’s Data Center shall provide a copy of this order to each of the parties in Case Nos. EO-2023-0369 and EO-2023-0370.
2. Any party in Case Nos. EO-2023-0369 and EO-2023-0370 may be a party to this case by filing a notice of intention to participate no later than June 22, 2026.
3. The Commission’s Data Center shall serve a copy of this order upon the county commissions of each county in the service areas of Evergy Missouri Metro and Evergy Missouri West.
4. The Commission’s Public Policy and Outreach Department shall make notice of this order available to the news media serving the residents of the service areas of Evergy Missouri Metro and Evergy Missouri West.
5. Any applications to intervene shall be filed no later than June 22, 2026.
6. Staff shall file its recommendation no later than July 2, 2026.

7. This order shall be effective when issued.
