5	Q.	Please state your name and business address.	
6	Α.	My name is David Desmond. My business address is 2331 59 th Street, St.	
7	Louis, Missouri 63110.		
8	Q.	By whom and in what capacity are you employed?	
9	А.	I am employed by Local Union No. 2, International Brotherhood of Electrical	
10	Workers ("Local 2") as Business Manager and Financial Secretary.		
11	Q.	Please describe Local 2 and the employees that it represents.	
12	А.	Local 2 represents AmerenUE's outside physical workers in the Jefferson City	
13	area, as well as employees in the Company's and part of the Central Ozarks, Missouri Valley,		
14	Boon Trails Divisions including Capital District, Wentzville District, Little Dixie District and		
15	Green Hills District in central and west Missouri. Local 2 also represents some of		
16	AmerenUE's substation employees. Local 2 also represents about 300 members in other		
17	utility companies and cooperatives in Missouri.		
18	Q.	How many AmerenUE employees does Local 2 represent?	
19	Α.	Local 2 represents approximately 300 employees at AmerenUE.

1	Q.	What roles do the employees represented by Local 2 play in the	
2	operations of AmerenUE?		
3	А.	Those employees range from the people you may see restoring your service	
4	during a storm	to all of the support groups that are necessary to get that job done. They also	
5	perform substation work which includes general maintenance and switching work.		
6	Q.	Please describe your duties on behalf of Local 2.	
7	А.	As Business Manager, I have responsibility for representation of employees of	
8	several utility and employers in Missouri. My duties include contract negotiation and		
9	administration along with organizing the unorganized workers in these industries. As		
10	Financial Secretary, I have responsibility for the finances of our union.		
11	Q.	Please describe your employment history and involvement in Local 2 and	
12	your employment history with AmerenUE.		
13	А.	I have been employed with AmerenUE as a lineman for 20 years and have	
14	been the Assistant Business Manager for Local 2 for eight years and Business Manager for		
15	two years.		
16	Q.	What is the purpose of your testimony?	
17	А.	The purpose of my testimony is to provide support for AmerenUE's proposed	
18	rate increase and to express concerns about the impact of the proposed rate reductions		
19	suggested of t	the Commission Staff ("Staff"), the State of Missouri through the Attorney	
20	General's office, and certain other parties on AmerenUE, and also on the AmerenUE		
21	employees represented by Local 2. AmerenUE's proposed rate increase to recover its cost of		
22	service and its large investments in utility plant will enable the company to continue to		
23	provide quali	ty service to its Missouri electric customers and also to continue to provide jobs

to the employees represented by Local 2. The employees of Local 2 are proud of their 1 2 accomplishments in working for a company that provides quality service at one of the lowest rates in the region. It is my understanding that this is the first rate increase AmerenUE has 3 4 requested in nearly 20 years. Indeed, even with the proposed rate increase AmerenUE's rates 5 will still be among the lowest in the country. 6 Q. What is Local 2's overall concern with the proposed reductions to 7 AmerenUE's rates? 8 Such huge rate cuts would be a strange way to reward all of us who have Α. 9 made AmerenUE such a successful, efficient supplier of electricity. Also, we are concerned that reductions of this magnitude will jeopardize AmerenUE's ability to provide quality 10 11 service to its electric retail customers in Missouri. We are concerned that such a dramatic 12 rate reduction would not provide the Company with sufficient funds to invest in much needed 13 infrastructure improvements in generation, transmission and distribution. 14 Q. What is your understanding of the rate and revenue proposals which 15 AmerenUE is making in this proceeding? 1.6 Α. It is my understanding that AmerenUE is proposing to increase rates in order 17 to recover increases in its cost of service, including pay and benefits for our members as well 18 as billions of dollars of capital investments it has made in the State of Missouri. A portion of 19 the rate increase is also due to AmerenUE's proposal to enhance its tree trimming practices 20 to "harden" its system against damage from future storms like the severe storms that hit the 21 St. Louis area in 2006.

Q. Does Local 2 support AmerenUE's proposals? A. Yes, we do. Local 2 supports AmerenUE's rate increase request because it will allow not only our members, but all of us who are the men and women of AmerenUE, to continue to provide the high quality service we have in the past, and more than ever need to do in the future. Q. Does this conclude your testimony?
