ORDER RECOGNIZING NAME CHANGE

Issue Date: June 4, 2026

Effective Date: June 19, 2026

On May 20, 2026, the Commission received a letter from KLM Long Distance Company d/b/a Fastwyre Broadband advising that it has;

- changed its corporate form from a corporation to a limited liability company;
- changed its name to KLM Long Distance Company, LLC reflective of the changed corporate form; and
- changed its fictitious name to Socket Fiber.

KLM Long Distance Company also submitted a tariff adoption notice and updated title page, assigned Tracking No. JI-2026-0143 with an effective date of June 19, 2026.¹ KLM Long Distance Company was granted authority to provide intrastate interexchange and local exchange telecommunications services in Case No. TA-2000-789.

The Commission has reviewed the filings and Commission Rule 20 CSR 4240-28.011(2) and finds the company has complied with all statutory and regulatory

requirements for changing its name. The Commission will recognize the name change and approve the submitted tariff sheets.

The Commission finds it reasonable for this order to become effective in less than 30 days.

THE COMMISSION ORDERS THAT:

1. The Commission recognizes the name change of KLM Long Distance Company d/b/a Fastwyre Broadband to KLM Long Distance Company, LLC d/b/a Socket Fiber.

2. The tariff adoption sheet and updated title page, filed and corrected on May 20, 2026, and assigned Tracking No. JI-2026-0143, is approved to become effective on June 19, 2026.

3. This order shall become effective on June 19, 2026.

4. This case shall close on June 20, 2026.
