On June 5, 2026,¹ the Staff of the Commission (Staff) filed a *Motion to Suspend Tariff and Extend Filing Date for Staff Recommendation* in which it requested an extension to July 1, 2026, in which to file its recommendation on the revised tariff sheets filed by Union Electric Company d/b/a Ameren Missouri on May 22 with an effective date of June 21. Accordingly, Staff also requested that the revised tariff sheets be suspended.

The Commission will set a deadline for responses to Staff’s motion.
