On March 26, 2021, Union Electric Company d/b/a Ameren Missouri (Ameren Missouri) filed an Motion for Leave To File Corrected Surrebuttal Testimony. Ameren Missouri explains that Steven Willis used numbers from the wrong column in one of Staff's rebuttal testimony workpapers, leading to the presentation of inaccurate information on page 20 of his surrebuttal testimony. Ameren Missouri seeks to correct that error with corrected surrebuttal testimony.

No party has objected. The Commission finds the motion reasonable, and will grant it.
