**ORDER CONTINUING HEARING AND
SUSPENDING PROCEDURAL SCHEDULE**

Effective Date: April 14, 2021

On February 17, 2021, the Commission issued a procedural schedule and set a hearing on April 30, 2021, to receive testimony regarding exhibits offered after the evidentiary hearing conducted in this case on September 24, 2020, as well as testimony and other evidence concerning Staff’s supplemental report, filed on December 21, 2020.

On April 12, 2021, the Staff of the Commission (Staff) filed a request to cancel the evidentiary hearing, which was submitted on behalf of Staff; Barbara Edwards, Complainant; and Evergy Missouri West, Inc. d/b/a Evergy Missouri West (Evergy West), Respondent. The *Joint Request to Cancel Evidentiary Hearing* states that Ms. Edwards has agreed to accept a “goodwill credit of \$310.51” to resolve the billing issues related to the post-hearing exhibits and Staff’s supplemental report. Staff, Ms. Edwards and Evergy West request the Commission cancel the hearing set for April 30, 2021.¹

¹ The Office of the Public Counsel (OPC) has made no filings in this case. Nor has OPC filed notice of intent not to participate.

On April 13, 2021, the Commission issued a notice of proposed partial dismissal of the complaint and directed that any responses regarding the proposed settlement be filed no later than April 26, 2021.

Under these circumstances, the hearing scheduled for April 30, 2021, will be continued. The Commission will suspend the procedural schedule.

THE COMMISSION ORDERS THAT:

1. The hearing scheduled for April 30, 2021, is continued until further order.
2. The procedural schedule is suspended.
3. This order shall be effective when issued.
