ORDER APPROVING INTERIM RATES

Issue Date: May 4, 2011 Effective Date: May 25, 2011

On March 25, 2011, Union Electric Company, d/b/a Ameren Missouri filed a tariff sheet¹ reflecting a change to the company's Fuel and Purchased Power Adjustment rates under the Fuel Adjustment Clause approved by the Commission.² The tariff sheet bears an effective date of May 25 and will result in the following adjustment in the Fuel and Purchased Power rates:

Service	Current rate	Proposed rate	Difference
Secondary	\$0.00479kWh	\$0.00419/kWh	-\$0.00060/kWh
Primary	\$0.00464/kWh	\$0.00406/kWh	-\$0.00058kWh
Large Transmission	\$0.00450/kWh	\$0.00393/kWh	-\$0.00057/kWh

On April 22, the Staff of the Commission filed a Memorandum recommending that the Commission approve the proposed adjustment, subject to true-up and prudence reviews, to go into effect on May 25. Staff states that the adjustment will apply to the billing period of June 2011 through May 2012 and, based on a monthly usage of 1,100 kWh, the

adjustment will result in a decrease of \$0.66 in residential customer's bills, from \$5.27 to \$4.61. Staff goes on to recommend that Ameren has complied with the Commission's Report and Order in Case No ER-2010-0036 regarding the Fuel Adjustment Clause. Staff states that Ameren has also complied with Commission rule 4 CSR 240-3.161 and the company's tariff.

The Commission has reviewed the application and Staff's Memorandum and Recommendation and, based on the verified pleadings, finds that the proposed tariff sheet conforms to Ameren's approved Fuel Adjustment Clause. The Commission will therefore approve the tariff sheet to go into effect on May 25, 2011.

THE COMMISSION ORDERS THAT:

1. The following proposed tariff sheet, filed on March 25, 2011, by Union Electric Company, d/b/a Ameren Missouri and assigned tracking number YE-2011-0485, is approved to go into effect on May 25, 2011, on an interim basis, subject to true-up and prudence reviews:
