**ORDER GRANTING EXTENSION OF TIME TO FILE
JOINT PROPOSED PROCEDURAL SCHEDULE**

On June 3, 2026,¹ the Commission ordered the parties to collaborate on a joint proposed procedural schedule to be filed by the Staff of the Commission no later than June 10.

On June 10, Union Electric Company d/b/a Ameren Missouri filed a *Motion for Extension of Time to File Joint Procedural Schedule*, requesting an extension to June 30 to allow the parties to further discuss whether the case can be resolved without the need for an evidentiary hearing. The motion states that none of the other parties opposes the motion.

The Commission finds the motion reasonable and will grant it.

THE COMMISSION ORDERS THAT:

1. The motion for an extension of time to file a joint proposed procedural schedule is granted. The parties shall collaborate on a joint proposed procedural schedule to be filed by the Staff of the Commission no later than June 30, 2026.
