**ORDER SUSPENDING TARIFF SHEETS  
AND GRANTING EXTENSION FOR STAFF RECOMMENDATION**

On May 22, 2026,<sup>1</sup> Union Electric Company d/b/a Ameren Missouri filed revised tariff sheets purporting to implement the terms of the *Order Approving Stipulation and Agreement and Granting Certificate of Convenience and Necessity* issued by the Commission on October 23, 2024. The tariff sheets bear an effective date of June 21 and have been assigned Tracking No. JE-2026-0145.

The Commission set a time for responses to the revised sheets and directed its Staff to file a recommendation. On June 5, Staff filed a *Motion to Suspend Tariff and Extend Filing Date for Staff Recommendation*. The Commission set a time for responses, and, on June 10, Ameren Missouri filed a response stating that it did not object to Staff’s motion. No other responses to the motion were filed.

The Commission will grant Staff’s unopposed motion and extend the time for Staff to file its recommendation regarding the revised tariff sheets. The Commission will also suspend the effective date of the revised tariff sheets for a period of 30 days.

**THE COMMISSION ORDERS THAT:**

1. The tariff sheets filed by Ameren Missouri on May 22, 2026, assigned Tracking No. JE-2026-0145, are suspended until July 21, 2026.
2. Staff shall file a recommendation regarding the revised tariff sheets no later than July 1, 2026.
3. Any responses to Staff's recommendation shall be filed no later than July 8, 2026.
4. This order shall be effective when issued.
