PROPOSED AMENDMENT

20 CSR 4240-29.020 Definitions. The Public Service Commission is amending sections (17) and (34).

PURPOSE: This proposed amendment updates the rule citations in the rule from 4 CSR 240 to the current rule locations in 20 CSR 4240. This amendment also corrects statutory citations of sections 386.020(29) and 386.020(51), RSMo, to sections 386.020(30) and 386.020(52), RSMo.

(17) LATA (Local Access and Transport Area) means that term as defined in section [386.020(29), RSMo Supp. 2004] **386.020(30), RSMo.**

(34) Telecommunications Company means those companies as set forth by section [386.020(51), RSMo Supp. 2004] **386.020(52), RSMo.**

AUTHORITY: sections 386.040 and 386.250, RSMo [2000] 2016. This rule originally filed as 4 CSR 240-29.020. Original rule filed Nov. 30, 2004, effective July 30, 2005. Moved to 20 CSR 4240-29.020, effective Aug. 28, 2019. Amended: Filed, effective.*
