## ORDER ESTABLISHING TIME TO INTERVENE AND DIRECTING STAFF TO FILE A RECOMMENDATION

On April 15, 2021, Evergy Missouri West, Inc., d/b/a Evergy Missouri West ("Evergy West") filed steam tariff sheets (Tracking No. JH-2021-0183) to change the calculation of Evergy West's Quarterly Cost Adjustment ("QCA") rider for steam service. The tariff sheets have a proposed effective date of June 1, 2021. The Commission will direct the Staff of the Missouri Public Service Commission to file a recommendation on Evergy West's tariff sheets. A deadline will be set for any other party to file a response to the tariff sheets or Staff's recommendation.

### THE COMMISSION ORDERS THAT:

1. Any person wishing to intervene in this matter shall file an application to intervene no later than May 4, 2021. The application shall be filed in the Commission's Electronic Filing and Information System (EFIS) or with the Secretary of the Commission.
2. Staff shall file its recommendation regarding Evergy's West's tariff sheets no later than May 14, 2021.
3. Any party wishing to comment on the tariff sheets or Staff's recommendation shall do so no later than noon on May 17, 2021.

4. This order shall be effective when issued.
