## ORDER RECOGNIZING NAME CHANGE

Issue Date: April 21, 2021

Effective Date: May 1, 2021

MCI Communications Services, LLC d/b/a Verizon Business Services submitted a letter on April 2, 2021, advising that it has changed its name from MCI Communications Services, Inc. d/b/a Verizon Business Services to reflect its conversion from a corporation to a limited liability company. The company also filed updated tariffs to reflect the new name. Those tariffs carry an effective date of April 3, 2021. Subsequently, the company submitted a letter to cancel one of its tariffs, Tariff No. JX-2006-0523.

On April 20, 2021, the Commission's Staff filed a recommendation indicating the company has complied with all statutory and regulatory requirements for changing its name. Staff recommends the Commission recognize the name change, recognize the cancellation of the indicated tariff, and allow the updated tariffs to take effect by operation of law. The Commission will do so.

### THE COMMISSION ORDERS THAT:

1. The Commission recognizes MCI Communications Services, Inc. d/b/a Verizon Business Services' name change to MCI Communications Services, LLC d/b/a Verizon Business Services.

2. The revised tariffs filed by MCI Communications Services, LLC d/b/a Verizon Business Services (Tariff Nos. JX-2021-0179 and JX-2021-0180) took effect on April 3, 2021.

3. MCI Communications Services, LLC d/b/a Verizon Business Services Tariff No. JX-2006-0523 is cancelled.

4. This order shall be effective on May 1, 2021.

5. This file shall be closed on May 2, 2021.
