ORDER DIRECTING STAFF TO FILE A RECOMMENDATION

The Commission directed its Staff (Staff) to file a pleading informing the Commission whether Staff would be able to file a recommendation by June 26, 2026, about Evergy Metro, Inc. d/b/a Evergy Missouri Metro’s (Evergy Metro) application to issue debt securities. Staff responded that it would be unable to complete a recommendation by that date because there were outstanding data requests not due until July 1, 2026.

Staff’s response stated: “Staff submitted a follow-up DR as recently as June 11, 2026, to which a response is due by July 1, 2026, as shown in the Commission’s Electric Filing and Information System.” Staff can see the status of data requests in EFIS. However, Regulatory Law Judges cannot see data requests or their status in EFIS because that would provide inappropriate access to parties’ discovery.

Staff requested to have until July 3, 2026, to submit a recommendation, but July 3, 2026, is a state holiday. Therefore, the Commission will direct its Staff to file a recommendation no later than July 6, 2026. The Commission will also set a time for responses.

THE COMMISSION ORDERS THAT:

1. Staff shall file a recommendation or status report regarding this complaint no later than July 6, 2026.
2. Any responses to Staff's recommendation or Evergy Metro's application are due no later than July 9, 2026.
3. This order is effective when issued.
