On June 23, 2026, Evergy Metro, Inc., d/b/a Evergy Missouri Metro, filed a motion to amend the Commission’s order setting a procedural schedule. Specifically, Evergy Missouri Metro requested the virtual local public hearing set for August 17, 2026, be moved to September 10, 2026, so that Evergy Missouri Metro could provide sufficient customer notice of the hearing. Evergy Missouri Metro stated that the Staff of the Commission had no objection to this change. However, no other party’s opinion on the change was noted. Therefore, the Commission will direct that any party wishing to respond to Evergy Missouri Metro’s motion, shall do so no later than June 29, 2026.
