**ORDER GRANTING SECOND EXTENSION FOR STAFF RECOMMENDATION**

On March 24, 2026,<sup>1</sup> Confluence Rivers Utility Operating Company, Inc. (Confluence Rivers) filed an application regarding acquisition of the sewer system assets of the Consolidated Public Water Supply District No. 1 of Knox County. The Commission directed its Staff (Staff) to file a recommendation by April 29, later extended to June 29.

On June 29, Staff filed a second request for an extension of time to file its recommendation due to outstanding data requests and the need for further discovery. Staff requested an extension of 30 days and stated that Confluence Rivers did not object to the requested extension.

The Commission finds the requested extension to be reasonable and will grant it.

**THE COMMISSION ORDERS THAT:**

1. Staff’s request for an extension of time is granted. Staff shall submit its recommendation no later than July 29, 2026.
