ORDER DISMISSING CASE

Issue Date: June 30, 2026

Effective Date: July 30, 2026

On September 15, 2022, Jack and Tammy Duncan (Applicants) filed the above-styled application. The Staff of the Commission (Staff) filed its Recommendation on December 22, 2023, advising the Commission to deny the application.

The Commission set a prehearing conference for January 18, 2024. Applicants did not appear. The Commission issued an Order to Show Cause on February 26, 2024, giving Applicants until March 7, 2024 to explain their failure to appear. Applicants did not respond. The Commission issued a Second Order to Show Cause on March 8, 2024. Applicants responded on March 18, 2024, stating that they have given all the information that they have. Applicants further ask the Commission to proceed without their attendance.

Commission Rule 20 CSR 4240-2.116(3) states that the Commission may dismiss a case for failure to appear at a prehearing conference. Commission Rule 20 CSR 4240-2.116(4) states that the Commission may dismiss a case for good cause after a minimum of ten days' notice to all parties involved. Applicants failed to appear at a prehearing conference, and Applicants

have been given ten days' notice that their application may be dismissed. Applicants further ask the Commission to proceed without them. Thus, the Commission will dismiss this case.

Under Commission Rule 20 CSR 4240-2.070(14), the regulatory law judge shall cause the parties to be notified that the dismissal will be final unless an application for rehearing is filed. The application for rehearing must be filed with the Commission within 30 days, which is July 30, 2026.¹

If the Commission denies the application for rehearing, the parties then have 30 days after the denial is issued to file an appeal with the court of appeals.² If the Commission grants the application for rehearing, then the Commission will order appropriate actions at that time.

THE COMMISSION ORDERS THAT:

1. The application is dismissed without prejudice.
2. If Applicants wish to request a rehearing by the Commission, such request must be filed before July 30, 2026.
3. This order shall be effective on July 30, 2026.
