On August 2, 2021, the Commission ordered the parties to file a status report no later than February 1, 2022. The Commission's Staff timely filed a status report on behalf of the parties. This proceeding is currently stayed while the parties await the outcome of File No. AW-2018-0394, which may change the Affiliate Transactions Rule affecting this proceeding. Staff states that no further progress has occurred in this proceeding or File No. AW-2018-0394. Staff states that information related to a Fully Distributed Cost Study was provided with Ameren Missouri's workpapers in ER-2021-0240 and GR-2021-0241. Accordingly, the Commission will continue the stay and order the parties to file another status report.

1. The parties shall file a status report no later than July 29, 2022.
