NEXTERA ENERGY TRANSMISSION SOUTHWEST, LLC'S
QUARTERLY UPDATE

Pursuant to the Missouri Public Service Commission's February 6, 2026 *Order Directing Development of Wildfire Mitigation Plans* ("Order"), electric corporations were directed to develop wildfire mitigation and preparedness plans containing specified minimum components and to provide a final draft plan to Commission Staff no later than December 31, 2026. The Order provides that electric corporations provide Commission Staff quarterly updates on the development of their wildfire mitigation and preparedness plans, with the first update due no later than March 31, 2026.

NextEra Energy Transmission Southwest, LLC ("NEET Southwest") is an electric corporation and currently operates transmission infrastructure in Barton and Jasper Counties in Missouri, which is part of the Wolf Creek-Blackberry 345 kV Transmission Project ("WCB Project"). While the WCB Project is approximately 92 miles total, only nine miles are in Missouri in Barton and Jasper Counties with the other 83 miles traversing five counties in Kansas. The WCB Project is NEET Southwest's only asset in Missouri at this time.

For its quarterly update, NEET Southwest provides that it is in the process of drafting a Wildfire Mitigation and Preparedness Plan that conforms with the Commission's directive and expects to complete such plan by the Commission's December deadline. As referenced in NEET Southwest's Response to Information Requests, filed in the above-captioned docket on June 30,

2025, NEET Southwest currently utilizes the Wildfire Response Plan of its affiliate, Lone Star Transmission, LLC, and will use that Plan until NEET Southwest creates a Wildfire Mitigation and Preparedness Plan that conforms with the Commission's requirements.
