On April 13, 2017, KCP&L Greater Missouri Operations Company filed its 2016 Renewable Energy Standard Compliance Report and 2017 Renewable Energy Standard Compliance Plan, as required by Commission Rule 4 CSR 240-20.100(8).

The Commission will direct notice and establish a deadline for Staff to file a report and for other interested entities to file comments.<sup>1</sup>

**THE COMMISSION ORDERS THAT:**

1. The Commission's Data Center shall provide notice of this order upon each party to KCP&L Greater Missouri Operations Company's most recent rate case, File Number ER-2016-0156.

2. The Commission's Data Center shall serve a copy of this order upon the county commission of each county within KCP&L Greater Missouri Operations Company's service area.

<sup>1</sup> Commission Rule 4 CSR 240-20.100(8)(D) and (E) provide that Staff shall, and other interested persons or entities may, file comments 45 days after the report is filed. In this case, that 45-day deadline would fall on Sunday, May 28. The next day that is not a weekend or a holiday is Tuesday, May 30.

3. The Commission's Public Information Office shall make notice of this order available to the members of the General Assembly representing KCP&L Greater Missouri Operations Company's service area and to the news media serving KCP&L Greater Missouri Operations Company's service area.

4. The Staff of the Missouri Public Service Commission shall examine KCP&L Greater Missouri Operations Company's 2016 Renewable Energy Standard Compliance Report and 2017 Renewable Energy Standard Compliance Plan and shall file a report of its review no later than May 30, 2017.

5. No later than May 30, 2017, the Office of the Public Counsel, and any other interested person or entity, may file comments regarding KCP&L Greater Missouri Operations Company's 2016 Renewable Energy Standard Compliance Report and 2017 Renewable Energy Standard Compliance Plan.

6. This order shall be effective when issued.
