**SECOND MOTION FOR EXTENSION OF TIME TO FILE
A STATUS REPORT OR JOINT PROPOSED PROCEDURAL SCHEDULE**

COMES NOW Union Electric Company d/b/a Ameren Missouri ("Ameren Missouri"), and for its *Second Motion for Extension of Time to File a Status Report or Joint Proposed Procedural Schedule* respectfully states to the Missouri Public Service Commission ("Commission") as follows:

1. On June 11, 2026, the Commission issued its *Order Granting Extension of Time to File Joint Proposed Procedural Schedule*, allowing the parties until June 30, 2026, to file a joint proposed procedural schedule. The extension of time was to allow Ameren Missouri, Co-Mo Electric Cooperative, Inc. ("Co-Mo"), and Mr. Eversole to further discuss whether the case can be resolved without the need for an evidentiary hearing.

2. Ameren Missouri, Co-Mo and Mr. Eversole have held discussions and have agreed to continue discussions to determine whether this matter can be resolved without the need for an evidentiary hearing. To allow time for additional discussions, Ameren Missouri requests an extension of time until July 21, 2026, to file a status report or joint proposed procedural schedule.

3. The undersigned counsel has discussed this filing with Mr. Eversole, and counsel for the Staff of the Commission, the Office of Public Counsel, and Co-Mo, all of which have stated they do not oppose an extension until July 21, 2026, to allow additional discussions.

WHEREFORE, Ameren Missouri requests the Commission extend the time to file a status report or joint proposed procedural schedule from June 30, 2026, until July 21, 2026.
