**ORDER GRANTING EXTENSION OF TIME TO FILE
JOINT PROPOSED PROCEDURAL SCHEDULE**

On June 11, 2026,¹ the Commission granted an extension of time and ordered the parties to collaborate on a joint proposed procedural schedule to be filed by the Staff of the Commission no later than June 30.

On June 30, Union Electric Company d/b/a Ameren Missouri filed a Second Motion for Extension of Time to File Joint Procedural Schedule, requesting an extension to July 21 to allow the parties to further discuss whether the case can be resolved without the need for an evidentiary hearing. The motion states that none of the other parties opposes the motion.

The Commission finds the motion reasonable and will grant it.

THE COMMISSION ORDERS THAT:

1. The motion for an extension of time to file a joint proposed procedural schedule is granted. The parties shall collaborate on a joint proposed procedural schedule to be filed by the Staff of the Commission no later than July 21, 2026.
