On June 23, 2026, the Commission issued an order directing its Staff (Staff) to file a recommendation regarding the request of Evergy Metro, Inc. d/b/a Evergy Missouri Metro (Evergy Metro) to issue debt securities. Staff was directed to file a recommendation no later than July 6, 2026, and Evergy Metro was given until July 9, 2026, to respond to Staff's recommendation.

Staff filed a recommendation about Evergy Metro's application on July 1, 2026. Therefore, the Commission will shorten the time for Evergy Metro's response.

THE COMMISSION ORDERS THAT:

1. Any response by Evergy Metro to Staff's recommendation must be filed no later than July 2, 2026.
2. This order is effective when issued.
