ORDER GRANTING REQUEST FOR AN EXTENSION

On January 16, 2026, The Empire District Electric Company d/b/a Liberty filed a 60-day notice of intended case filing for a large load tariff case.

On July 1, 2026, Liberty filed a motion requesting an extension of time beyond 180 days to file its large load tariff case. Liberty asks to have an additional 30 days to file its case.

The Commission will grant the motion for an extension.

THE COMMISSION ORDERS THAT:

1. Liberty's motion is granted. Liberty shall file its large load tariff case no later than August 14, 2026.
2. This order is effective when issued.
