On May 28, 2026, Spire Missouri Inc. (Spire) filed the above-referenced application. Spire seeks a certificate of convenience and necessity (CCN) to construct, install, own, operate, maintain, and otherwise control and manage a natural gas distribution system to provide gas service to 60 farm taps which Spire has agreed to purchase from Southern Star Central Gas Pipeline, Inc.

The Commission directed notice of the application, and it received no intervention requests. Thus, the Commission will order its' Staff to file a Recommendation.

THE COMMISSION ORDERS THAT:

1. The Staff of the Commission shall file a Recommendation or alternative pleading no later than July 23, 2026.
2. This order shall be effective when issued.
