ORDER DIRECTING RESPONSE TO MEDIATION REQUEST

Issue Date: July 9, 2026

Effective Date: July 9, 2026

On June 9, 2026, Steven Granier filed a complaint with the Commission against Union Electric Company d/b/a Ameren Missouri. On June 15, 2026, the Commission issued its *Notice of Complaint and Order Directing Answer and Staff Report*, which also mentioned the possibility of mediation.

Mediation is an informal method of dispute resolution in which the parties voluntarily agree to participate. No party relinquishes any rights by agreeing to participate in mediation.

On July 8, 2026, Ameren Missouri filed a *Request for Mediation*, which stated its desire to mediate the complaint.

The Commission will direct Mr. Granier to file a response stating whether he agrees to mediation of his complaint.

THE COMMISSION ORDERS THAT:

1. No later than July 20, 2026, Mr. Granier shall file a response to Ameren Missouri's mediation request, stating whether he agrees to enter into mediation.

2. All other actions on this case shall cease and all time limitations and previously ordered deadlines are tolled until the Commission rules on Ameren Missouri's meditation request.

3. This order is effective when issued.
