NOTICE THAT TARIFF SHEETS WILL GO INTO EFFECT

Issue Date: July 9, 2026

On May 22, 2026,¹ Union Electric Company d/b/a Ameren Missouri filed revised tariff sheets purporting to implement the terms of the *Order Approving Stipulation and Agreement and Granting Certificate of Convenience and Necessity* issued by the Commission on October 23, 2024. The tariff sheets bear an effective date of June 21 and have been assigned Tracking No. JE-2026-0145. At the request of the Staff of the Commission, the Commission suspended that tariff until July 21, 2026.

To incorporate language missing from the Commission's order, Ameren Missouri also filed Tracking No. JE-2026-0160 on June 12, 2026. That tariff bears an effective date of July 11, 2026.

On July 1, 2026, Staff filed a Recommendation. Staff recommends that the Commission approve both tariffs.

The Commission issues this notice that the Commission will allow Tracking No. JE-2026-0145 and JE-2026-0160 to take effect by operation of law.
