**APPLICATION TO INTERVENE OF WARRENTON DC OWNER 1 LLC
AND WARRENTON DC OWNER 2 LLC**

Warrenton DC Owner 1 LLC and Warrenton DC Owner 2 LLC (jointly, "Warrenton DC Owners"), pursuant to 20 CSR 4240-2.075 of the Missouri Public Service Commission's Rules of Practice and Procedure and for their Application to Intervene, respectfully state as follows:

1. Warrenton DC Owners plan to site a new hyperscale enterprise data center near Warrenton, Missouri. That facility will be served by Ameren Missouri.

2. On June 26, 2026, Union Electric Company d/b/a Ameren Missouri submitted tariff sheets to produce a net increase in its electric base rates of approximately \$343 million.

3. On June 30, 2026, the Commission issued its Order Giving Notice, setting a deadline to intervene, setting a deadline to respond to the test year, and directing a proposed schedule.

4. Warrenton DC Owners seek to intervene because the Commission's actions herein could affect Warrenton DC Owners' interests.

5. Warrenton DC Owners will be among Ameren's largest customers, such that they have an interest in this proceeding different from that of the general public. Warrenton DC Owners' interest will not and cannot be adequately represented by any other party.

6. Warrenton DC Owners do not yet have a position on the issues in this case and reserve the right to take positions on specific issues as this case

after review of discovery and additional information to be adduced during the pendency of the proceeding.

7. Warrenton DC Owners' intervention will serve the public interest by assisting the development of the record for the Commission's decision in this case.
