ORDER APPROVING TARIFF

On July 8, 2026, the Commission granted Spire Missouri Inc. d/b/a Spire a certificate of convenience and necessity. Later that same day, Spire filed Tariff Tracking No. JG-2027-0005 to comply with the Commission's July 8, 2026 order. The tariff bears an effective date of August 7, 2026. The Commission's Staff filed a Recommendation on July 20, 2026. The Recommendation stated that the Commission should approve the tariffs. No other responses were received.

The Commission finds that the tariff complies with the Commission's July 8, 2026 order. The Commission will approve the tariff.

THE COMMISSION ORDERS THAT:

1. The tariff filed by Spire on July 8, 2026, and assigned Tracking No. JG-2027-0005 is approved to become effective on August 7, 2026.
2. This order shall be effective August 7, 2026.
