On May 28, 2026, Spire Missouri Inc. (Spire) filed the above-referenced application. Spire seeks a certificate of convenience and necessity (CCN) to construct, install, own, operate, maintain, and otherwise control and manage a natural gas system to provide natural service in Platte County, Missouri.

The Commission directed notice of the application, and it received no intervention requests. The Commission ordered its' Staff to file a Recommendation or alternative pleading no later than July 23, 2026.

On July 21, 2026, Staff asked for an extension of time until August 24, 2026, to file its Recommendation. Staff indicates that Spire does not object.

The Commission finds the request reasonable and will grant it.

THE COMMISSION ORDERS THAT:

1. The Staff of the Commission shall file a Recommendation or alternative pleading no later than August 24, 2026.
2. This order shall be effective when issued.
