On June 9, 2026,¹ Steven Granier filed a complaint against Union Electric Company d/b/a Ameren Missouri.

On July 8, Ameren Missouri filed a *Request for Mediation*, which stated its desire to mediate the complaint.

On July 9, the Commission ordered Mr. Granier to file his response to the mediation request. Mr. Granier's response was due July 20. No response has been filed.

The Commission will set a procedural conference to discuss next steps. For their convenience, the parties may appear by telephone or computer as set out below. The
