ORDER DIRECTING STAFF TO FILE A RECOMMENDATION AND SETTING TIME FOR RESPONSES

Issue Date: July 23, 2026

Effective Date: July 23, 2026

On June 25, 2026, the Commission directed its Staff (Staff) to file a pleading stating when Staff could file a recommendation about Confluence Rivers Utility Operating Company, Inc.'s (Confluence Rivers) application for a certificate of convenience and necessity (CCN). Staff states that it can file a recommendation by September 20, 2026. Because that date falls on a weekend, the Commission will extend the due date to the following Monday.

The Commission will order its Staff to file a recommendation regarding Confluence Rivers' application and set a time for any responses.

THE COMMISSION ORDERS THAT:

1. Staff must file its recommendation regarding Confluence Rivers' CCN application no later than September 21, 2026.
2. Any responses to Staff's recommendation or Confluence Rivers' CCN application must be filed no later than October 2, 2026.

3. This order is effective when issued.
