## ORDER RECOGNIZING NAME CHANGE

On May 26, 2016, tw telecom of kansas city llc filed a letter informing the Commission that it has changed the name by which it provides telecommunications service in Missouri to Level 3 Telecom of Kansas City, LLC.

Staff filed a recommendation on June 16, advising the Commission that the notice of name change complies with the Commission's requirements for a name change, and recommending that the Commission allow the related tariffs filed by the company to go into effect by operation of law. No one has opposed the name change.

The Commission has reviewed the notice of name change and Staff's recommendation. The Commission finds that the name change should be recognized. The Commission notes that Level 3 Telecom of Kansas City, LLC's tariff adoption notice will become effective by operation of law on June 26.

### **THE COMMISSION ORDERS THAT:**

1. The Commission recognizes the change of name of tw telecom of kansas city llc to Level 3 Telecom of Kansas City, LLC.

2. This order shall be effective when issued.
3. This file shall be closed on June 17, 2016.
