ORDER RECOGNIZING NAME CHANGE

On December 12, 2016, Chariton Valley Telecom Corporation filed notice that it is changing the name under which it provides telecommunications service in Missouri to Chariton Valley Communications Corporation, effective on December 31, 2016. The company has also filed appropriate tariffs to adopt the tariffs filed under the previous name of the company. Those tariff changes will go into effect on December 31, 2016, by their terms. The Staff of the Commission responded on December 23, indicating the company has complied with all statutory and regulatory requirements for changing its name. Staff recommends the Commission recognize the name change, and allow the tariff changes to take effect by operation of law. The Commission will do so.

THE COMMISSION ORDERS THAT:

1. The Commission recognizes the name change of Chariton Valley Telecom Corporation to Chariton Valley Communications Corporation.
2. This order shall be effective when issued.


