**MISSOURI-AMERICAN WATER COMPANY’S  
COMMENTS ON PROPOSED AMENDMENTS AND PROPOSED RESCISSION OF  
THE COMMISSION’S RULES RELATING TO  
CHAPTER 3 – FILING REQUIREMENTS**

**COMES NOW** Missouri-American Water Company (“MAWC” or “Company) and provides its Comments concerning Proposed Amendments and Proposed Rescission of the Commission’s Rules Relating to Chapter 3- Filing Requirements (“Proposed Rule”) and, in support, states as follows:

1. On May 28, 2026, the Commission issued a Finding of Necessity and Order Directing Proposed Amendment and Proposed Rescission Be Filed for Publication.
2. On May 29, 2026, the Commission made an Initial Filing of proposed Rulemaking and Amendment with the Secretary of State.
3. On June 3, 2026, the Commission issued a Notice of Hearing and Comment Period establishing that comments must be received on or before July 31, 2026, and scheduling a public hearing regarding the proposed rule for August 5, 2026.
4. This Proposed Rule specifically addresses amendments to and rescission of portions of Chapter 3 – Filing Requirements, with the majority of the proposed changes intended to update rule and statutory citations.

5. MAWC is generally supportive the proposed rules and provides no further comment at this time.

**WHEREFORE**, MAWC respectfully requests the Commission consider these Comments and, thereafter, take any action it deems reasonable and necessary.
