## ORDER SHORTENING TIME FOR RESPONSES TO NUNC REQUEST

On August 5, 2026,<sup>1</sup> The Empire District Electric Company d/b/a Liberty filed a *Motion for an Order Nunc Pro Tunc and Expedited Treatment* (Motion). In sum, the Motion indicates that Liberty's recently approved FAC tariff sheet in one case was mistakenly superseded by a filing including the same FAC tariff sheet in a separate case. Liberty requests the Commission issue a *nunc pro tunc* order to correct the situation.

The Commission will direct the Staff of the Commission (Staff) to file a response and will set a time for other responses. Those time frames will be shortened as Liberty has requested expedited treatment.

### THE COMMISSION ORDERS THAT:

1. Staff shall file a response to the Motion, or a statement when they expect to be able to file a response no later than 2:00 p.m. on August 6, 2026.
