**JOINT SUBMISSION OF FIRST ADDENDUM TO  
TERRITORIAL AGREEMENT**

**COMES NOW**, Central Missouri Electric Cooperative, Inc. (“CMEC”) and Evergy Missouri West, Inc. d/b/a Evergy Missouri West (“Evergy”), each by and through counsel, jointly submit their First Addendum to Territorial Agreement and, with respect thereto, state as follows:

1. CMEC and Evergy are parties to a Stipulation and Agreement submitted in File No. EO-2026-0070 on June 25, 2026 (the “Stipulation”). Appendix 1 to the Stipulation is a June 24, 2026 Territorial Agreement (the “Agreement”) entered into by CMEC and Evergy.
  
2. CMEC and Evergy have agreed to modify the Agreement pursuant to a First Addendum to the Territorial Agreement dated August 6, 2026, which is attached hereto as Exhibit “1”.

**WHEREFORE**, CMEC and Evergy respectfully request that the Commission approve the Stipulation and the Territorial Agreement, as amended by the First Addendum to Territorial Agreement, and grant any other and further relief as it deems just and equitable.
