ORDER EXTENDING REBUTTAL TESTIMONY DEADLINE

On July 8, 2026,¹ the Commission issued its *Order Setting Procedural Schedule*. The procedural schedule included a deadline of August 7 for Staff/Intervener Rebuttal.

On August 7, the Staff of the Commission (Staff) filed its *Motion for Extension of Deadline to File Rebuttal Testimony*, stating that development of its rebuttal testimony was nearly complete, but additional time to finalize components of the testimony was required. Thus, Staff requested an extension of the deadline to August 11. Staff's motion stated that no parties object to the request.

The Commission finds the motion reasonable and will grant it.

THE COMMISSION ORDERS THAT:

1. Staff's *Motion for Extension of Deadline to File Rebuttal Testimony* is granted.
2. The deadline for parties to file rebuttal testimony is extended to August 11, 2026.
3. This order shall be effective when issued.
