## JOINT REQUEST FOR EXTENSION OF TIME FOR FILING STATEMENT OF POSITIONS

COMES NOW the Staff of the Missouri Public Service Commission ("Staff"), by and through the Staff Counsel's Office, on behalf of the "Parties" in File Nos. EA-2013-0098 and EO-2012-0367, i.e., the Staff, the Office of the Public Counsel ("OPC"), Missouri Industrial Energy Consumers ("MIEC"), and the Applicants Transource Missouri, LLC ("Transource Missouri"), Kansas City Power & Light Company ("KCP&L"), and KCP&L Greater Missouri Operations Company ("GMO"), and files this *Joint Request For Extension Of Time For Filing Statement Of Positions* from April 10, 2013 to April 11, 2013. In support thereof, the Staff states as follows:

1. On March 29, 2013, the Commission at the request of the Parties issued an *Order Rescheduling Hearing And Extending Time For Position Statements* in which it

- 3. In order to continue settlement discussions, the Parties now request a one day extension of time to file their Statement of Positions from Wednesday, April 10, 2013, to Thursday, April 11, 2013.
- 4. The Parties do not make this request to unduly delay the proceedings or vex the Commission.
