SUBJECT: Staff Recommendation On Ameren Missouri's Tariff Sheets Filed to Comply with the  
Commission's Order Approving Report and Order And Request For Expedited Treatment

DATE: May 14, 2015

On April 29, 2015, the Missouri Public Service Commission (Commission) issued its Report and Order (Order) in Case No. ER-2014-0258, the Union Electric Company d/b/a Ameren Missouri (Ameren Missouri or Company) electric case. This Order approved an increase in the Company's overall Missouri jurisdictional gross annual electric revenues of approximately \$108 million. On May 1, 2015, the Commission issued a Notice of Updated Calculation of Financial Effect of Report and Order ("Notice"). This Notice states that Ameren Missouri's approved overall jurisdictional gross annual electric revenues are approximately \$121.5 million.

The Company filed tariff sheets on May 6, 2015, to comply with the Order. In its letter of transmittal accompanying the April 29, 2015 compliance filing, Ameren Missouri requested expedited treatment to reflect an effective date of May 30, 2015, which would be less than the standard 30-day period, but which complies with the Commission's suspension of Ameren Missouri's original tariff filing in this case.

The Commission's Energy Unit - Tariffs/Rate Design, Economic Analysis and Energy Resource Analysis Staff (Staff) has reviewed the tariff sheets as filed by Ameren Missouri on May 6, 2015, and is of the opinion that these sheets are in compliance with the Commission's Order. Staff is also of the opinion that good cause for approval of these tariff sheets on less than thirty days notice is demonstrated by the Commission's Order Directing Staff to File Expedited Recommendation and Establishing Time For Other Parties to Offer Recommendations. Therefore, Staff recommends the following tariff sheets filed on May 6, 2015, be approved:
