SECOND ORDER GRANTING REQUEST FOR AN EXTENSION

On January 16, 2026, The Empire District Electric Company d/b/a Liberty filed a 60-day notice of intended case filing for a large load tariff case. On July 1, 2026, Liberty filed a motion requesting an extension to file its large load tariff case. The Commission granted Liberty until August 14, 2026, to file its large load case.

On August 11, 2026, Liberty filed a second motion for an extension of time requesting to have until September 14, 2026, to file its large load case. On August 13, 2026, Liberty followed its extension request with a motion for expedited treatment.

The Commission will grant Liberty's second motion for an extension.

THE COMMISSION ORDERS THAT:

1. Liberty's motion for a further extension is granted. Liberty shall file its large load tariff case no later than September 14, 2026.
2. This order is effective when issued.
