On behalf of Timber Creek Sewer Company (“TCSC” or “Company”), I am providing herewith to the Missouri Public Service Commission (“Commission”) for filing the following sewer tariff sheet in electronic form:

P.S.C. MO No. 3, 1st Revised Sheet No. 9, Canceling Original Sheet No. 9

The proposed tariff sheet bears a date of issue of August 13, 2026, and an effective date of September 12, 2026.

This tariff sheet is being filed to correct two commercial rates that were transposed in the original sheet and, thus, in this respect were not consistent with the *Nonunanimous Agreement Regarding Disposition of Small Water Company Revenue Increase Request* that was approved by the Commission’s *Order Approving Disposition Agreement and Compliance Tariff Sheets Implementing a Small Company Rate Increase* issued August 12, 2026.

Concurrently with the filing of this tariff sheet, TCSC will also file a *Motion for Expedited Treatment* requesting that this sheet become effective on August 31, 2026.

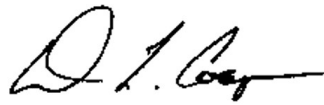
