MOTION FOR EXPEDITED TREATMENT

COMES NOW Timber Creek Sewer Company ("TCSC"), and for its *Motion for Expedited Treatment* pursuant to Commission Rule 20 CSR 4240-2.080(14), respectfully states as follows to the Missouri Public Service Commission ("Commission"):

1. On August 12, 2026, the Commission issued its *Order Approving Disposition Agreement and Compliance Tariff Sheets Implementing a Small Company Rate Increase* (the "Order"). The Order included approval, effective August 30, 2026, of TCSC's proposed compliance tariff sheets submitted on July 31, 2026, and assigned Tracking No. JS-2027-0017.

2. After the Commission's Order was approved, it was discovered that two of the commercial rates found in Original Sheet No. 9 of the approved tariffs had been transposed. Each of these commercial rates applies to a single customer.

3. TCSC seeks to correct the tariff sheet as expeditiously as possible and has filed *P.S.C. MO No. 3, 1st Revised Sheet No. 9, Canceling Original Sheet No. 9* for this purpose. The revised tariff sheet has been identified by the Commission as Tracking No. JS-2027-0026. Although the tariff sheet bears an effective date 30 days after issuance, TCSC requests that the tariff sheet be allowed to take effect for service rendered on and after August 31, 2026, or as soon thereafter as is reasonable.

4. Pursuant to Commission Rule 20 CSR 4240-2.080(14), TCSC submits that the tariff sheet is being filed to be fully consistent with the rates contemplated by the Commission's Order. Therefore, a grant of this Motion would be consistent with the public interest. TCSC

further states that this Motion is being filed as quickly as possible after the issue discussed herein was discovered.

5. Counsel for the Staff of the Commission and counsel for the Office of the Public Counsel have indicated that they have no objection to this Motion.

WHEREFORE, TCSC respectfully requests an order of the Commission granting this motion and allowing the revised tariff sheet, Tracking No. JS-2027-0026, to take effect for service rendered on and after August 31, 2026, or as soon thereafter as is reasonable.
