STAFF'S RECOMMENDATION TO REJECT OR, ALTERNATIVELY, TO SUSPEND TARIFF SHEETS

COMES NOW the Staff of the Missouri Public Service Commission and for its recommendation to reject or, alternatively, to suspend tariff sheets states:

- 1. On January 16, 2013, Kansas City Power & Light Company filed tariff sheets it asserted comply with the Commission's September 2, 2015, *Report and Order* in this case.
- 2. Contemporaneously, Kansas City Power & Light Company filed a motion requesting the Commission to clarify or reconsider its decisions regarding the definitions of off-system sales revenues ("OSSR") and the "J" component of its fuel adjustment clause, and a separate motion requesting the Commission make its tariff sheets effective on September 15, 2015, asserting good cause exists to make them effective on less than the thirty days' notice required by § 393.140(11), RSMo, "because the Commission has already found that KCP&L is presently in a revenue deficient position of approximately \$245,000 per day on average, and the Commission has already authorized and directed KCP&L to file the tariffs that are filed concurrently with the filing of this Motion."
- 3. In the attached Memorandum, the Staff of the Missouri Public Service Commission recommends that the Commission issue an Order which rejects or, alternatively, suspends the tariff sheets Kansas City Power & Light Company filed on

January 16, 2013, because they do not comply with the Commission's Report and Order in that KCPL's proposed fuel adjustment clause language (1) does not include the phrase "revenue sufficiency and revenue neutrality" the Commission ordered and (2) KCPL's proposed definition of the "J" component does not account for the differences in the line losses in Kansas and Missouri, and, therefore, would shift costs from Kansas to Missouri.

4. Staff has verified that Kansas City Power & Light Company has filed its annual report and is not delinquent on any assessment. Further, Staff unaware of any other matter before the Commission that affects or is affected by this tariff sheet filing.

WHEREFORE, Staff requests the Commission issue an Order that rejects or, alternatively, suspends the following proposed Kansas City Power & Light Company tariff sheets, as filed on September 8, 2015, with substitutions on September 11, 2015:

DATE: September 14, 2015

On September 2, 2015, the Missouri Public Service Commission (Commission) issued its Report and Order ("Order") in Case No. ER-2014-0370, Kansas City Power & Light Company's ("KCPL") general electric rate increase request case. This Order approved an increase in KCPL's overall Missouri jurisdictional gross annual electric revenues of approximately \$89.7 million. In it the Commission ordered KCPL to file compliance tariff sheets by September 8, 2015, and for Staff to file its recommendation on those sheets by September 14, 2015.

KCPL filed tariff sheets on September 8, 2015, it asserts comply with the Order. In an accompanying motion, KCPL requested the Commission to act on an expedited basis to approve the tariff sheets to become effective on September 15, 2015, which is less than the statutory standard 30-day period. KCPL filed substitute tariff sheets on September 11, 2015, to correct typos and to incorporate changes the Commission's Energy Unit – Tariffs/Rate Design, Economic Analysis and Energy Resource Analysis Staff (Staff) suggested to make the tariff sheets compliant with the Commission's Order.

On September 8, 2015, KCPL also filed a Motion for Clarification or Reconsideration with respect to its Fuel Adjustment Clause ("FAC") tariff sheets the definitions of the off-system sales revenues and the "J" component of the FAC. In Staff's opinion, the FAC tariff sheets 50.2, 50.3 and 50.4 do not comply with the Commission's Order. KCPL's proposed language did not include the phrase "revenue sufficiency and revenue neutrality" as ordered by the Commission and therefore, is not in compliance with the Commission order. KCPL's proposed "J" component of its FAC formula did not account for the differences in line losses between the Kansas and Missouri jurisdictions and as proposed, would shift costs from Kansas to Missouri.

Staff has reviewed the tariff sheets KCPL filed on September 8, 2015, with substitutions on September 11, 2015, and is of the opinion that they do not comply with the Commission's Order. Staff is also of the opinion that the Commission should reject, or suspend these tariff sheets.
