### STAFF RECOMMENDATION TO APPROVE SUBSTITUTE TARIFF SHEETS

**COMES NOW** the Staff of the Missouri Public Service Commission ("Staff") and for its recommendation to approve substitute tariff sheets states:

1. In the attached Memorandum (Appendix A), the Missouri Public Service Commission Staff ("Staff") recommends that the Commission issue an Order that approves the substitute tariff sheets KCP&L Greater Missouri Operations Company ("GMO") filed on January 26, 2017, and February 15, 2017, to become effective on February 22, 2017.<sup>1</sup>

2. The tariff sheets differ from those the Commission previously approved on November 30, 2016, only in that they revise from December 22, 2016, to February 22, 2017, certain dates to conform to the new effective date the Commission ordered on December 21, 2016, in response to GMO's request to extend the effective dates of the compliance tariff sheets it filed on November 8, 2016, including those it revised on November 17, 2016.

WHEREFORE, Staff recommends that the Commission issue an Order that approves the proposed tariff sheets GMO filed on January 26, 2017, and February 15, 2017, to become effective on February 22, 2017; the particular tariff sheets are identified in Appendix A.
