ORDER GRANTING EXPEDITE REQUEST AND APPROVING COMPLIANCE TARIFF SHEET

Issue Date: August 24, 2026

Effective Date: August 31, 2026

On August 12, 2026, the Commission issued its Order Approving Disposition Agreement and Compliance Tariff Sheets Implementing a Small Company Rate Increase (Order) in the above-captioned small utility rate case for Timber Creek Sewer Company (Timber Creek). The Order approved all submitted compliance tariff sheets, which are scheduled to become effective on August 30, 2026.

On August 14, 2026, Timber Creek submitted a new tariff sheet, assigned Tracking No. JS-2027-0026, with a submitted effective date of September 12, 2026. Timber Creek explained that the tariff sheet is being filed to correct two commercial rates that were unintentionally transposed in the original sheet which was approved by the Order. Timber Creek filed a request for expedited treatment and requested that the tariff sheet be allowed to take effect for service rendered on and after August 31, 2026, or as soon thereafter as reasonable.

The Commission directed the Staff of the Commission (Staff) to review the tariff sheet and provide its response. The Commission also set a time for other responses.

On August 21, 2026, Staff filed its Recommendation to Approve Tariff, stating that it

finds the tariff sheet to be in compliance with the Order. Staff also recommended that the tariff sheet be allowed to go into effect on August 31, 2026. No other responses were filed.

Upon reviewing the pleadings, the Commission finds Timber Creek's proposed tariff sheet complies with the Order and will approve it. To accommodate the unopposed request for expedited treatment, the Commission will make this order effective in less than thirty days and will approve the proposed tariff sheet to become effective on August 31, 2026.

THE COMMISSION ORDERS THAT:

1. Timber Creek's request for expedited treatment is granted.
2. The proposed tariff sheet, assigned Tracking No. JS-2027-0026, is approved to become effective on August 31, 2026. The specific tariff sheet is as follows:

3. This order shall become effective on August 31, 2026.
4. This case shall close on September 1, 2026.
